(2) Perintah ini mula berkuat kuasa pada 15 Disember 2011.

Pindaan Jadual

2. Perintah Pampasan Pekerja (Skim Pampasan Pekerja Asing) (Insurans) 2005 [*P.U. (A) 45/2005*] dipinda dalam Jadual—

(a) dengan menggantikan butiran “AmAssurance Berhad” dengan butiran “AmG Insurance Berhad”;

(b) dengan menggantikan butiran “Berjaya General Insurance Berhad” dengan butiran “Berjaya Sampo Insurance Berhad”;

(c) dengan memotong butiran “BH Insurance (M) Bhd”;

(d) dengan memasukkan selepas butiran “Commerce Takaful Berhad” dengan butiran yang berikut:

“Etiqa Insurance Berhad”

“Etiqa Takaful Berhad”;

(e) dengan menggantikan butiran “Hong Leong Tokio Marine Takaful Berhad” dengan butiran “Hong Leong MSIG Takaful Berhad”; dan

(f) dengan memotong butiran “Mayban General Assurance Berhad”, “Mayban Takaful Berhad”, “Malaysia National Insurance Berhad” dan “Takaful Nasional Sdn Berhad”.

WORKMEN'S COMPENSATION ACT 1952

WORKMEN'S COMPENSATION (FOREIGN WORKER'S COMPENSATION SCHEME)
(INSURANCE) (AMENDMENT) (NO. 3) ORDER 2011

IN exercise of the powers conferred by subsection 26(2) of the Workmen's Compensation Act 1952 [*Act 273*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) (Amendment) (No. 3) Order 2011**.

(2) This Order comes into operation on 15 December 2011.

Amendment of Schedule

2. The Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) Order 2005 [*P.U. (A) 45/2005*] is amended in the Schedule—

(a) by substituting for the item "AmAssurance Berhad" the item "AmG Insurance Berhad";

(b) by substituting for the item "Berjaya General Insurance Berhad" the item "Berjaya Sompo Insurance Berhad";

(c) by deleting the item "BH Insurance (M) Bhd";

(d) by inserting after the item "Commerce Takaful Berhad" the following items:
"Etiqa Insurance Berhad"
"Etiqa Takaful Berhad";

(e) by substituting for the item "Hong Leong Tokio Marine Takaful Berhad" the item "Hong Leong MSIG Takaful Berhad"; and

(f) by deleting the items “Mayban General Assurance Berhad”, “Mayban Takaful Berhad”, “Malaysia National Insurance Berhad” and “Takaful Nasional Sdn Berhad”.
