PERINTAH HAD LAJU (PERSIMPANGAN BERTINGKAT INDAH PURA) 2011

PADA menjalankan kuasa yang diberikan oleh subseksyen 69(2) Akta Pengangkutan Jalan 1987 [Akta 333], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Had Laju (Persimpangan Bertingkat Indahpura) 2011**.

(2) Perintah ini mula berkuat kuasa pada 8 Disember 2011.

Larangan

2. (1) Pemanduan suatu kenderaan motor dengan kelajuan yang melebihi had laju yang dinyatakan dalam ruang (2) Jadual Pertama di atas jalan yang dinyatakan dalam ruang (1) dilarang.

(2) Jalan dengan had laju yang dinyatakan di bawah subperenggan (1) ditunjukkan dalam peta dalam Jadual Kedua.

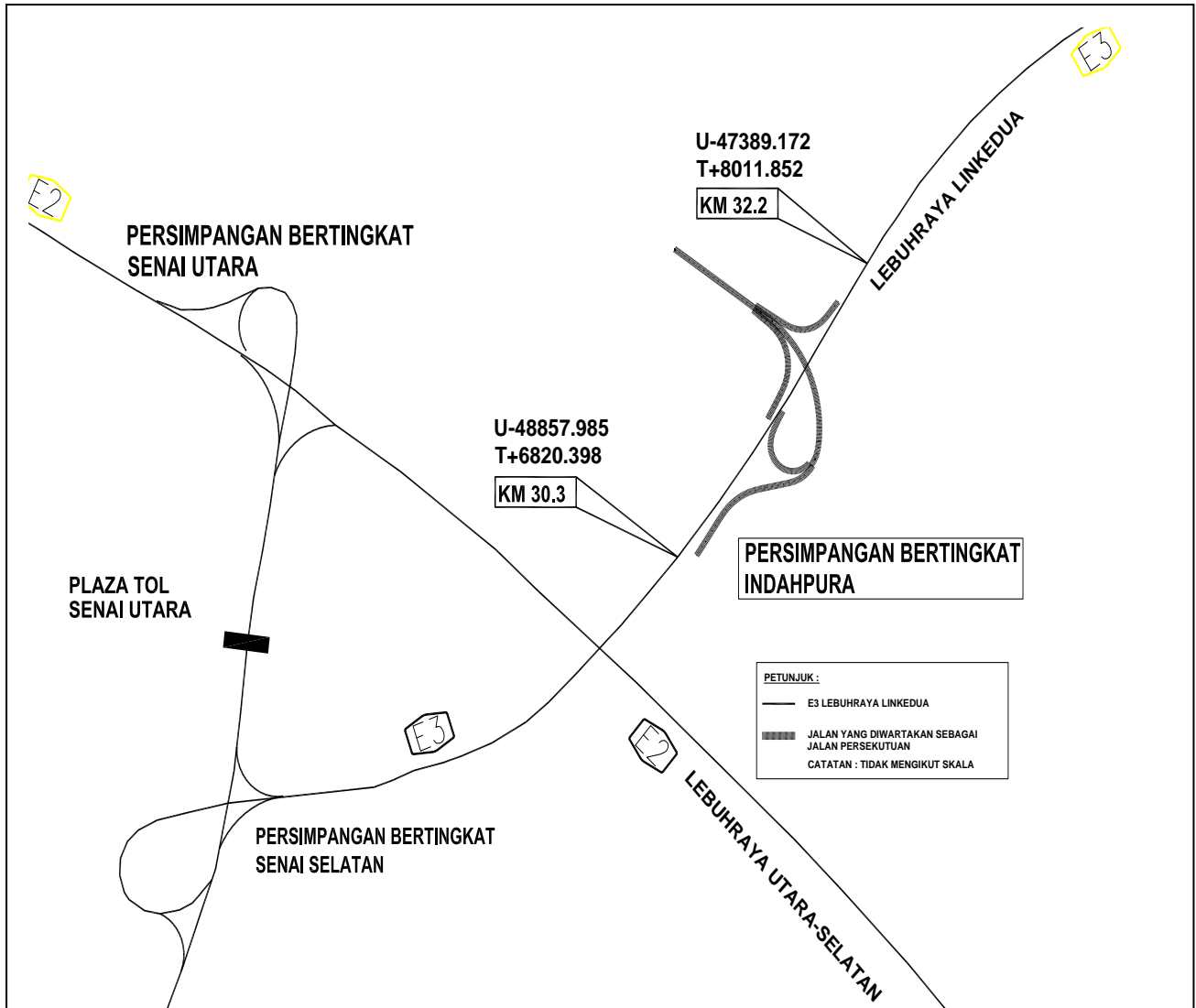

ROAD TRANSPORT ACT 1987

SPEED LIMIT (INDAHPURA INTERCHANGE) ORDER 2011

IN exercise of the powers conferred by subsection 69(2) of the Road Transport Act 1987 [Act 333], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Speed Limit (Indahpura Interchange) Order 2011**.

(2) This Order comes into operation on 8 December 2011.

Prohibition

2. (1) The driving of a motor vehicle at a speed exceeding the speed limit as specified in column (2) of the First Schedule on the road specified in column (1) is prohibited.

(2) The road with the speed limit as specified under subparagraph (1) is shown on the map in the Second Schedule.

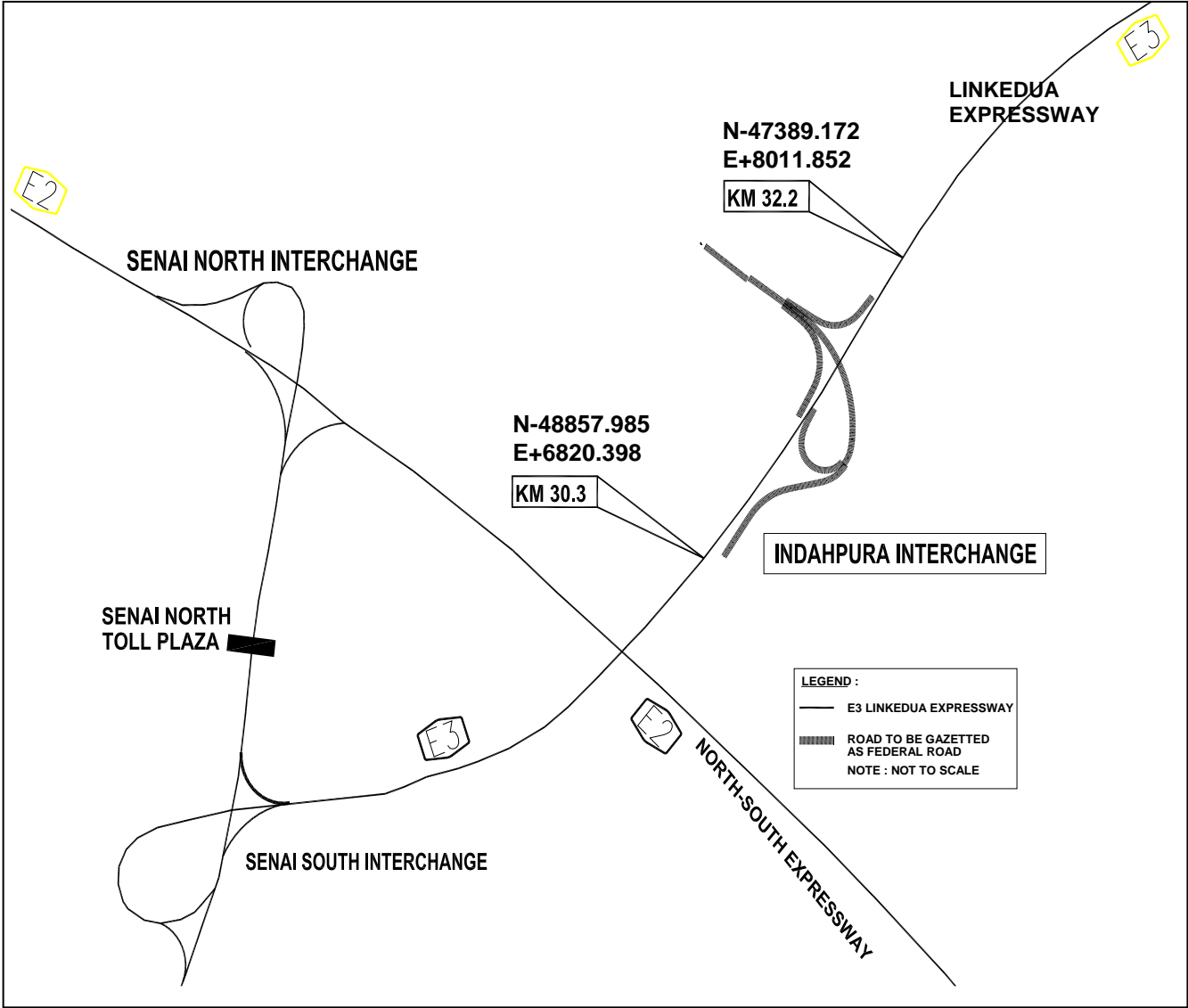
