PERINTAH SISTEM PEMBAYARAN (SISTEM PENGIRIMAN WANG YANG  
DILULUSKAN DI BAWAH AKTA PERNIAGAAN PERKHIDMATAN WANG 2011)  
(KETIDAKMASUKAN) 2011

PADA menjalankan kuasa yang diberikan oleh perenggan (f) mengenai takrif “sistem pembayaran” di bawah subseksyen 2(1) Akta Sistem Pembayaran 2003 [*Akta 627*], Bank Negara Malaysia membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Sistem Pembayaran (Sistem Pengiriman Wang yang Diluluskan di bawah Akta Perniagaan Perkhidmatan Wang 2011) (Ketidakmasukan) 2011**.

(2) Perintah ini mula berkuat kuasa pada 1 Disember 2011.

**Ketidakmasukan sistem pengiriman wang yang diluluskan di bawah Akta Perniagaan Perkhidmatan Wang 2011**

2. Takrif “sistem pembayaran” tidaklah termasuk sistem pengiriman wang yang telah diluluskan oleh Bank Negara Malaysia di bawah subseksyen 40(1) Akta Perniagaan Perkhidmatan Wang 2011 [*Akta 731*].

PAYMENT SYSTEM ACT 2003

PAYMENT SYSTEMS (REMITTANCE SYSTEM APPROVED UNDER THE MONEY SERVICES BUSINESS ACT 2011) (EXCLUSION) ORDER 2011

IN exercise of the powers conferred by paragraph *(f)* of the definition “payment system” under subsection 2(1) of the Payment System Act 2003 [*Act 627*], the Central Bank of Malaysia makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Payment Systems (Remittance System Approved Under the Money Services Business Act 2011) (Exclusion) Order 2011**.

(2) This Order comes into operation on 1 December 2011.

**Exclusion of remittance system approved under the Money Services Business Act 2011**

2. The definition of “payment system” does not include a remittance system which has been approved by the Central bank of Malaysia under subsection 40(1) of the Money Services Business Act 2011 [*Act 731*].
