FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(EAST-WEST LINK EXPRESSWAY) (REVOCATION) ORDER 2011

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (East-West Link Expressway) (Revocation) Order 2011**.

(2) This Order is deemed to have come into operation on 16 May 2011 at 8.30 p.m.

2. The Federal Roads (Private Management) (Collection of Tolls) (East-West Link Expressway) Order 2002 [*P.U. (A) 501/2002*] is revoked.
