NATIONAL SKILLS DEVELOPMENT (FEES AND CHARGES EXEMPTION TO MONTFORT  
YOUTH TRAINING CENTRE, KOTA KINABALU, SABAH) ORDER 2011

IN exercise of the powers conferred by subsection 73(1) of the National Skills Development Act 2006 [*Act 652*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **National Skills Development (Fees and Charges Exemption to Montfort Youth Training Centre, Kota Kinabalu, Sabah) Order 2011**.

**Exemption**

2. The Montfort Youth Training Centre which operates at Jalan Lama Penampang-Papar, Kinarut, 88200 Kota Kinabalu, Sabah is exempted from fees and charges for a period of three years commencing from 17 October 2011 to 16 October 2014 as required under item 3(a)(i) of the Schedule to the National Skills Development (Fees and Charges) Regulations 2006 [*P.U. (A) 409/2006*].
