NATIONAL SKILLS DEVELOPMENT ACT 2006

NATIONAL SKILLS DEVELOPMENT (FEES AND CHARGES EXEMPTION FOR
APPLICATION OF ACCREDITATION OF NATIONAL DUAL TRAINING SYSTEM
TRAINING PROVIDERS) ORDER 2011

IN exercise of the powers conferred by subsection 73(1) of the National Skills Development Act 2006 [*Act 652*], the Minister makes the following order:

Citation

1. This order may be cited as the **National Skills Development (Fees and Charges Exemption for Application of Accreditation of National Dual Training System Training Providers) Order 2011**.

Exemption

2. The application of Accreditation of National Dual Training System Training Providers which operate in Malaysia is exempted from the payment of fees and charges imposed under items 1 and 2 of the Schedule to the National Skills Development (Fees and Charges) Regulations 2006 [*P.U. (A) 409/2006*] with effect from 21 June 2011.
