NATIONAL SERVICE TRAINING (POSTPONEMENT OF LIABILITY) (AMENDMENT)
REGULATIONS 2011

IN exercise of the powers conferred by section 20(5) of the National Service Training Act 2003 [Act 628], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **National Service Training (Postponement of Liability) (Amendment) Regulations 2011**.

(2) These Regulations come into operation on 14 October 2011.

Amendment of Schedule

2. The National Service Training (Postponement of Liability) Regulations 2004 [P.U. (A) 26/2004] are amended by substituting for Form 4 in the Schedule the following Form:
