WORKMEN'S COMPENSATION ACT 1952

WORKMEN'S COMPENSATION (FOREIGN WORKERS' COMPENSATION SCHEME)
(INSURANCE) (AMENDMENT) (NO. 2) ORDER 2011

IN exercise of the powers conferred by subsection 26(2) of the Workmen's Compensation Act 1952 [*Act 273*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) (Amendment) (No. 2) Order 2011**.

(2) This Order comes into operation on 3 October 2011.

Amendment of Schedule

2. Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) Order 2005 [*P.U. (A) 45/2005*] is amended in the Schedule by inserting after the item "Malaysia National Insurance Berhad" item "**MSIG Insurance (Malaysia) Berhad**".
