## AKTA KASTAM 1967

## PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) (NO. 2) 2011

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) (No. 2) 2011**.

(2) Perintah ini mula berkuat kuasa pada 1 September 2011.

**Pindaan Jadual Kedua**

## CUSTOMS ACT 1967

## CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO. 2) ORDER 2011

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 2) Order 2011**.

(2) This Order comes into operation on 1 September 2011.

**Amendment of Second Schedule**

2. The Customs (Prohibition of Imports) Order 2008 [P.U. (A) 86/2008] is amended in the Second Schedule by inserting after item 41 the following item:
