PERINTAH JALAN-JALAN PERSEKUTUAN (PENGURUSAN PERSENDIRIAN)
(PUNGUTAN TOL) (LEBUH RAYA KEMUNING-SHAH ALAM) (PINDAAN) 2011

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Kemuning-Shah Alam) (Pindaan) 2011**.

(2) Perintah ini mula berkuat kuasa pada 22 Ogos 2011.

Pindaan perenggan 2

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Kemuning-Shah Alam) 2010 [*P.U. (A) 163/2010*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda—

(a) dalam subsubperenggan 2(1)(a), dengan menggantikan perkataan “Plaza Tol Taman Seri Muda, Persimpangan Bertingkat Seksyen 35” dengan perkataan “Plaza Tol Seri Muda, Persimpangan Bertingkat Alam Impian”; dan

(b) dalam subsubperenggan 2(1)(b), dengan menggantikan perkataan “Plaza Tol Seksyen 35” dengan perkataan “Plaza Tol Alam Impian”.

Pindaan perenggan 3

3. Perintah ibu dipinda dalam subperenggan 3(1), dengan menggantikan perkataan “Plaza Tol Taman Seri Muda atau Plaza Tol Seksyen 35” dengan perkataan “Plaza Tol Seri Muda atau Plaza Tol Alam Impian”.

Pindaan Jadual Pertama

4. Perintah ibu dipinda dalam Jadual Pertama—

(a) dalam Bahagian I di bawah ruang (2) —

(i) dengan menggantikan subtajuk “Plaza Tol Taman Seri Muda” dengan subtajuk “Plaza Tol Seri Muda”; dan

(ii) dengan menggantikan subtajuk “Plaza Tol Seksyen 35” dengan subtajuk “Plaza Tol Alam Impian”; dan

(b) dalam BAHAGIAN II di bawah ruang (2)—

(i) dengan menggantikan subtajuk “Plaza Tol Taman Seri Muda” dengan subtajuk “Plaza Tol Seri Muda”; dan

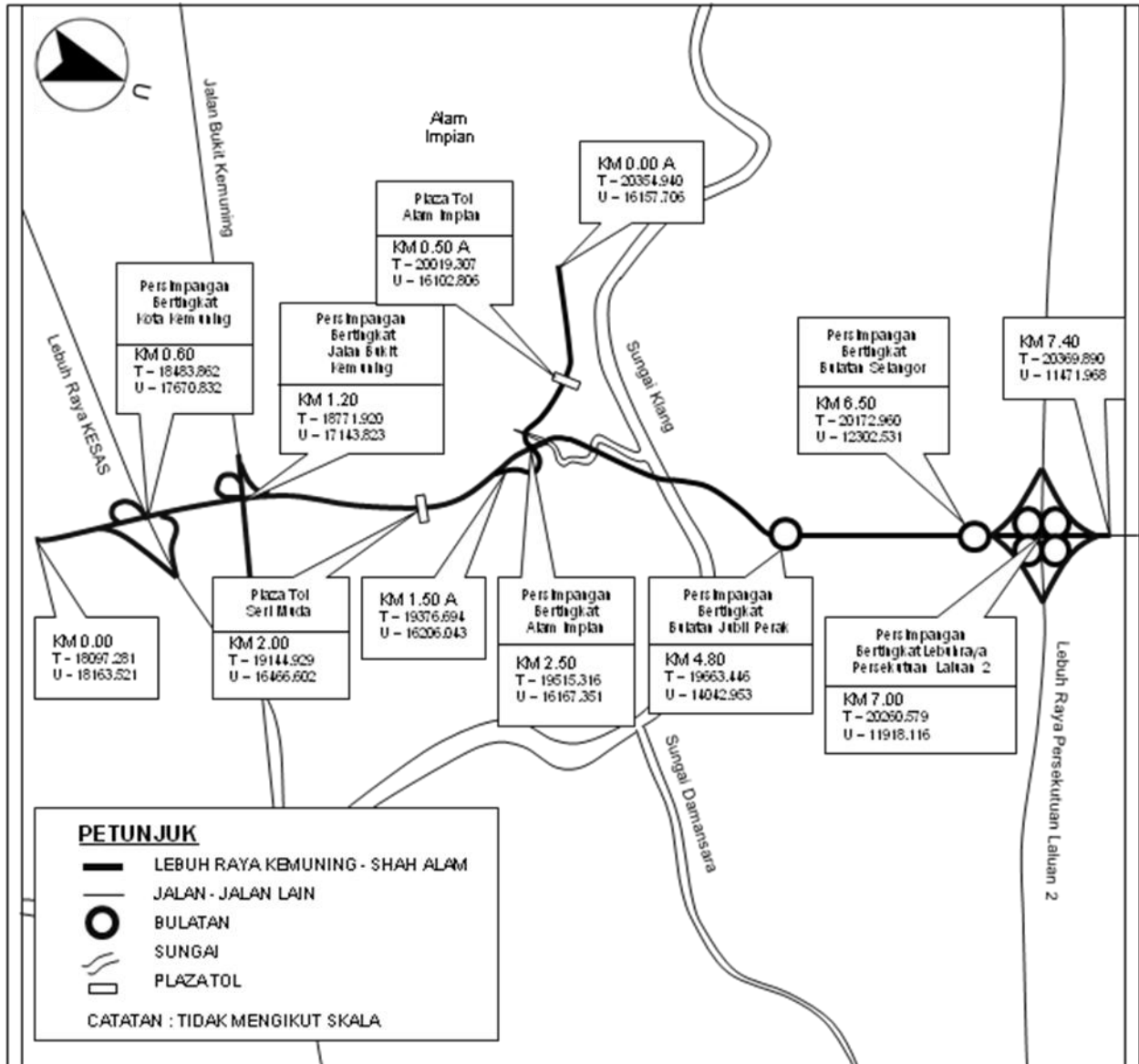
(ii) dengan menggantikan subtajuk “Plaza Tol Seksyen 35” dengan subtajuk “Plaza Tol Alam Impian”.

Pindaan Jadual Kedua

5. Perintah ibu dipinda dengan menggantikan Jadual Kedua dengan jadual yang berikut:

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(KEMUNING-SHAH ALAM HIGHWAY) (AMENDMENT) ORDER 2011

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Kemuning-Shah Alam Highway) (Amendment) Order 2011**.

(2) This Order comes into operation on 22 August 2011.

Amendment of paragraph 2

2. The Federal Roads (Private Management) (Collection of Tolls) (Kemuning-Shah Alam Highway) Order 2010 [*P.U. (A) 163/2010*], which is referred to as the “principal Order” in this Order, is amended—

(a) in subparagraph 2(1)(a), by substituting for the words “Taman Seri Muda Toll Plaza, Section 35 Interchange” the words “Seri Muda Toll Plaza, Alam Impian Interchange”; and

(b) in subparagraph 2(1)(b), by substituting for the words “Section 35 Toll Plaza” the words “Alam Impian Toll Plaza”.

Amendment of paragraph 3

3. The principal Order is amended in subparagraph 3(1), by substituting for the words “Taman Seri Muda Toll Plaza or Section 35 Toll Plaza” the words “Seri Muda Toll Plaza or Alam Impian Toll Plaza”.

Amendment of First Schedule

4. The principle Order is amended in the First Schedule—

(a) in PART I under column (2)—

(i) by substituting for the subheading “Taman Seri Muda Toll Plaza” the subheading “Seri Muda Toll Plaza”; and

(ii) by substituting for the subheading “Section 35 Toll Plaza” the subheading “Alam Impian Toll Plaza”; and

(b) in PART II under column (2)—

(i) by substituting for the subheading “Taman Seri Muda Toll Plaza” the subheading “Seri Muda Toll Plaza”; and

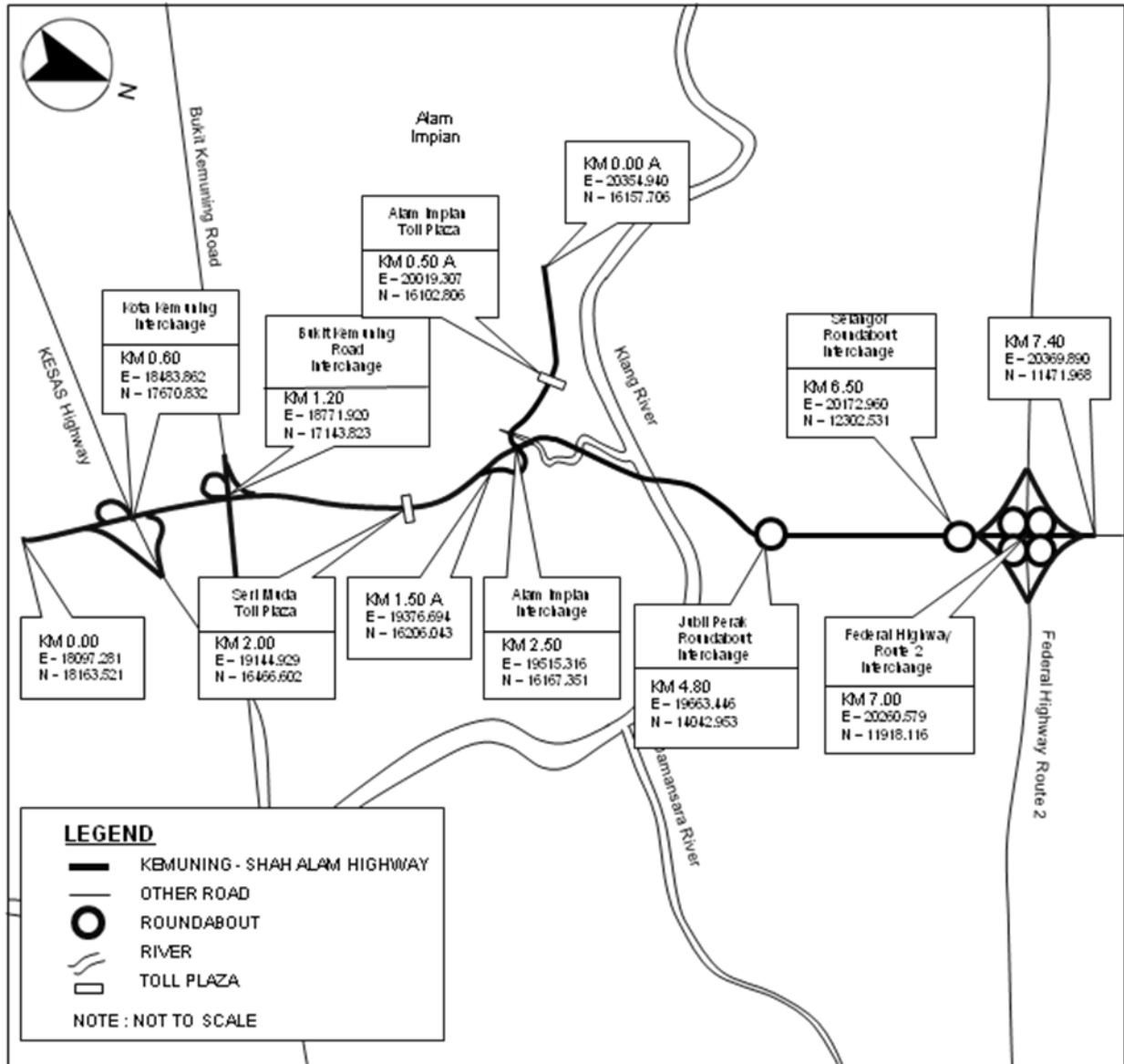
(ii) by substituting for the subheading “Section 35 Toll Plaza” the subheading “Alam Impian Toll Plaza”.

Amendment of Second Schedule

5. The principal Order is amend by substituting for the Second Schedule the following schedule:
