PORT AUTHORITY ACT 1963

JOHOR PORT AUTHORITY (SCALE OF CHARGES) (AMENDMENT) BY-LAWS 2011

IN exercise of the powers conferred by sections 16 and 29 of the Port Authority Act 1963 [*Act 488*], the Johor Port Authority with the approval of the Minister makes the following by-laws:

Citation and commencement

1. (1) These by-laws may be cited as the **Johor Port Authority (Scale of Charges) (Amendment) By-Laws 2011**.

(2) These By-Laws come into operation on 23 August 2011.

Amendment of Third Schedule

2. Part 14 of the Third Schedule to the Johor Port Authority By-Laws (Scales of Charges) 2011 [*P.U. (A) 175/2011*] is amended in subitem (1)(b) in column (3) by substituting for the word “5.10” the word “6.80”.
