PERATURAN-PERATURAN SEWA BELI (PERMOHONAN PERMIT DAN TATACARA
PEMILIKAN SEMULA BARANGAN) (PINDAAN) 2011

PADA menjalankan kuasa yang diberikan oleh perenggan 57(2)(b) Akta Sewa Beli 1967 [Akta 212], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Sewa Beli (Permohonan Permit dan Tatacara Pemilikan Semula Barangan) (Pindaan) 2011**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 4 Julai 2011.

Pindaan peraturan 4

2. Peraturan-Peraturan Sewa Beli (Permohonan Permit dan Tatacara Pemilikan Semula Barangan) 2011 [P.U. (A) 192/2011] dipinda dengan menggantikan peraturan 4 dengan peraturan yang berikut:

“4. Mana-mana orang yang ingin memohon permit untuk menjalankan pemilikan semula barangan yang terkandung dalam perjanjian sewa beli hendaklah memenuhi keperluan yang berikut:

(a) telah mencapai umur dua puluh satu tahun;

(b) seorang warganegara Malaysia; dan

(c) apa-apa keperluan lain yang boleh ditentukan oleh Pengawal.”.

HIRE-PURCHASE ACT 1967

HIRE-PURCHASE (APPLICATION OF PERMIT AND PROCEDURE OF REPOSSESSION)
(AMENDMENT) REGULATIONS 2011

IN exercise of the powers conferred by paragraph 57(2)(b) of the Hire-Purchase Act 1967 [Act 212], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Hire-Purchase (Application of Permit and Procedure of Repossession) (Amendment) Regulations 2011**.

(2) These Regulations come into operation on 4 July 2011.

Amendment of regulation 4

2. The Hire-Purchase (Application of Permit and Procedure of Repossession) Regulations 2011 [*P.U. (A) 192/2011*] is amended by substituting for regulation 4 the following regulation:

“4. Any person who desires to apply for a permit to undertake repossession of goods comprised in a hire-purchase agreement shall fulfill the following requirements:

(a) has attained the age of twenty-one years;

(b) is a Malaysian citizen; and

(c) any other requirement that may be determined by the Controller.”.
