PERINTAH UNIVERSITI SAINS MALAYSIA (PENGECCUALIAN) 2011

PADA menjalankan kuasa di bawah perenggan 26(a) Akta Universiti dan Kolej Universiti 1971 [*Akta 30*], Yang di-Pertuan Agong atas nasihat Menteri membuat perintah berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Universiti Sains Malaysia (Pengeccualian) 2011**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 1 Februari 2009.

**Pengeccualian daripada seksyen 2 dan subseksyen 16B(9) dan (11) Akta**

2. Yang di-Pertuan Agong mengeccualikan Universiti Sains Malaysia yang tertakluk kepada Akta Universiti dan Kolej Universiti 1971 daripada pemakaian tafsiran 'pelajar' di bawah seksyen 2 dan pemakaian subseksyen 16B(9) dan (11) Akta.

UNIVERSITIES AND UNIVERSITY COLLEGES ACT 1971  
UNIVERSITI SAINS MALAYSIA (EXEMPTION) ORDER 2011

IN exercise of the powers conferred by paragraph 26(a) of the Universities and University Colleges Act 1971 [Act 30], the Yang di-Pertuan Agong on the advice of the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Universiti Sains Malaysia (Exemption) Order 2011**.

(2) This Order is deemed to have come into operation on 1 February 2009.

**Exemption from section 2 and subsections 16B(9) and (11) of the Act**

2. The Yang di-Pertuan Agong exempts Universiti Sains Malaysia which is subject to the Universities and University Colleges Act 1971 from the application of the definition of 'student' in section 2 and application of subsections 16B(9) and (11) of the Act.
