## AKTA KASTAM 1967

## PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) 2011

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) 2011**.
- (2) Perintah ini mula berkuat kuasa pada 1 Julai 2011.

## CUSTOMS ACT 1967

## CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) ORDER 2011

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) Order 2011**.
- (2) This Order comes into operation on 1 July 2011.

**Amendment of Fourth Schedule**

2. The Customs (Prohibition of Imports) Order 2008 [*P.U. (A) 86/2008*] is amended in Part II of the Fourth Schedule, by inserting after item 8 and the particulars relating to the item the following item:
