PADA menjalankan kuasa yang diberikan oleh perenggan 86(2)(l) Akta Binatang 1953 [Akta 647], Menteri membuat kaedah-kaedah yang berikut:

**Nama**

1. Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Binatang (Fi Pemeriksaan Import dan Eksport) (Pindaan) 2011**.

**Pindaan Jadual Pertama**

2. Kaedah-Kaedah Binatang (Fi Pemeriksaan Import dan Eksport) 2010 [P.U. (A) 374/2010], yang disebut “Kaedah-Kaedah ibu” dalam Kaedah-Kaedah ini, dipinda dalam Jadual Pertama—

(a) dalam teks bahasa Inggeris, dalam butiran e, dengan memasukkan selepas perkataan “Cattle” perkataan “, buffalo”; dan

(b) dalam butiran g dan h, dengan menggantikan perkataan “seekor” dengan perkataan “setiap konsainan”.

**Pindaan Jadual Kedua**

3. Jadual Kedua Kaedah-Kaedah ibu dipinda, dalam teks bahasa Inggeris, dalam butiran e, dengan memasukkan selepas perkataan “Cattle” perkataan “, buffalo”.

ANIMALS ACT 1953

ANIMALS (IMPORT AND EXPORT EXAMINATION FEES) (AMENDMENT)  
RULES 2011

IN exercise of the powers conferred by paragraph 86(2)(l) of the Animals Act 1953 [Act 647], the Minister makes the following rules:

**Citation**

1. These rules may be cited as the **Animals (Import and Export Examination Fees) (Amendment) Rules 2011**.

**Amendment of First Schedule**

2. The Animals (Import and Export Examination Fees) Rules 2010 [P.U. (A) 374/2010], which are referred to as the “principal Rules” in these Rules, are amended in the First Schedule—

(a) in the English language text, in item e, by inserting after the word “Cattle” the words “, buffalo”; and

(b) in item g and h, by substituting for the word “head” the words “per consignment”.

**Amendment of Second Schedule**

3. The Second Schedule of the principal Rules is amended, in the English language text, in item e, by inserting after the word “Cattle” the words “, buffalo”.
