AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 8) 2011

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 8) 2011**.

(2) Perintah ini mula berkuat kuasa pada 13 Jun 2011.

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala “Negeri Pahang Darul Makmur” —

(a) dengan memasukkan selepas butiran 39 butiran yang berikut:

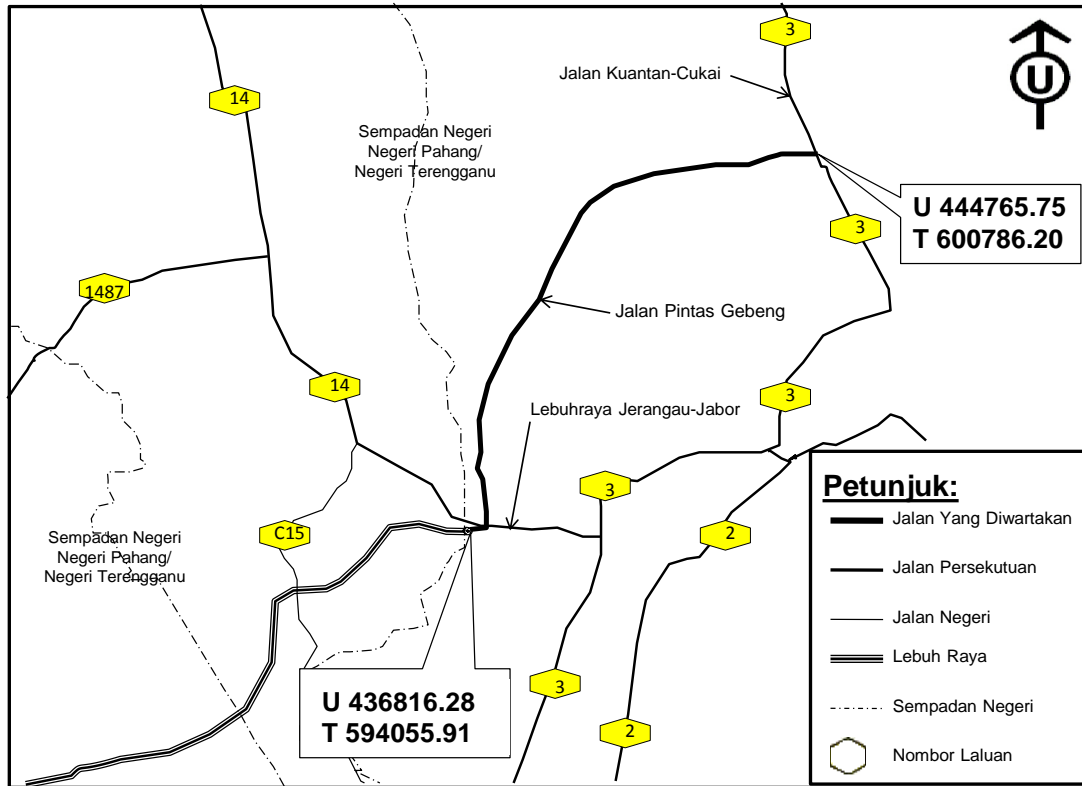
“40. *(Laluan 101): Jalan Pintas Gebeng*

Dari persimpangan bertingkatnya dengan Laluan 14, Lebuhraya Jerangau-Jabor termasuk jalan susurnya di koordinat Utara (U) 436816.28, Timur (T) 594055.91 dan berakhir di persimpangan bertingkat dengan Laluan 3, Jalan Kuantan-Cukai termasuk jalan susurnya di koordinat Utara (U) 444765.75, Timur (T) 600786.20 sebagaimana yang ditunjukkan dalam Peta 19: Negeri Pahang.

Jarak sepanjang 13.7 km.”; dan

(b) dengan memasukkan selepas PETA 18: NEGERI PAHANG peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT)(NO. 8 ) ORDER 2011

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Pahang, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 8) Order 2011**.

(2) This Order comes into operation on 13 June 2011.

**Amendment of First Schedule**

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading of “Negeri Pahang Darul Makmur” —

(a) by inserting after item 39 the following item:

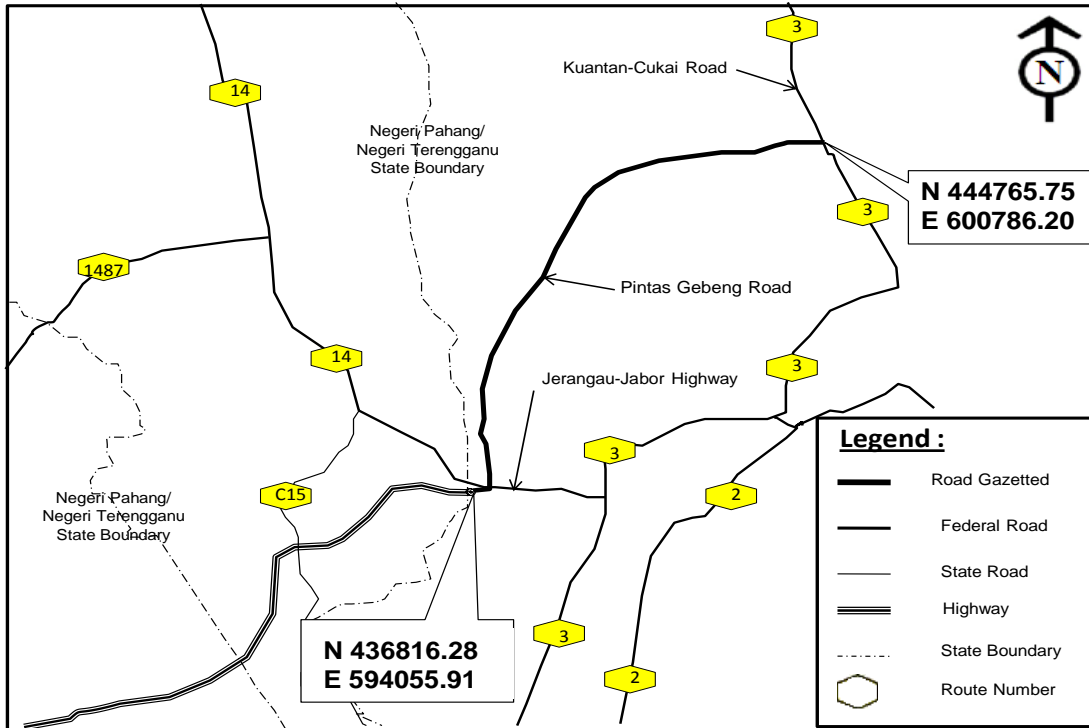
“40. *(Route 101): Pintas Gebeng Road*

From its interchange with Route 14, Jerangau-Jabor Highway including its slip road at coordinates North (N) 436816.28, East (E) 594055.91 and ending at the interchange with Route 3, Kuantan-Cukai Road including its slip road at coordinates North (N) 444765.75, East (E) 600786.20 as shown on Map 19: Negeri Pahang.

A distance of 13.7 km.”; and

(b) by inserting after MAP 18: NEGERI PAHANG the following map:
