Citation

1. This order may be cited as the **Factories and Machinery (Exemption to BASF Petronas Chemicals Sdn. Bhd., Kuantan, Pahang) Order 2009**.

Exemption

2. All unfired pressure vessels registered with the Chief Inspector, with the registration number and description as specified in columns (1) and (2) of the Schedule, in the name of BASF Petronas Chemicals Sdn. Bhd., Kuantan, Pahang which have been issued with certificates of fitness, are exempted from the preparation required under paragraph 17(*b*) of the Factories and Machinery (Notification, Certificate of Fitness and Inspection) Regulations 1970 [*P.U. (A) 43/1970*] for subsequent regular inspection after the expiry of such certificates of fitness on 2 May 2009.

Condition of exemption

3. The exemption under paragraph 2 is subject to the condition that all of the unfired pressure vessels as specified in the Schedule undergo external inspection and non-destructive tests and the Inspector is satisfied with the result of such inspection and tests.

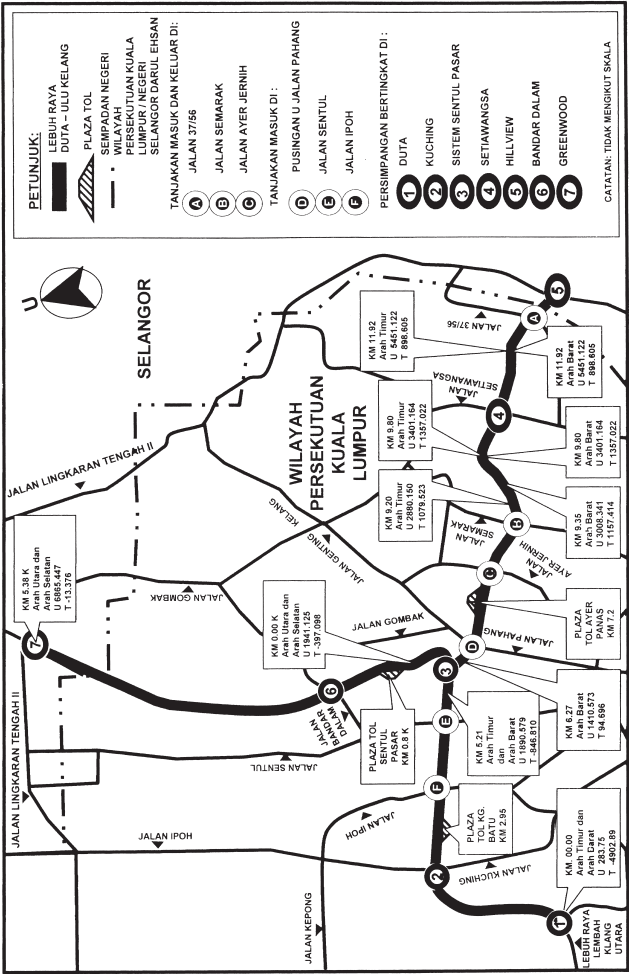

SPEED LIMIT (DUTA–ULU KELANG EXPRESSWAY) (AMENDMENT) ORDER 2009

IN exercise of the powers conferred by subsection 69(2) of the Road Transport Act 1987 [*Act 333*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Speed Limit (Duta–Ulu Kelang Expressway) (Amendment) Order 2009**.

(2) This Order comes into operation on 30 April 2009.

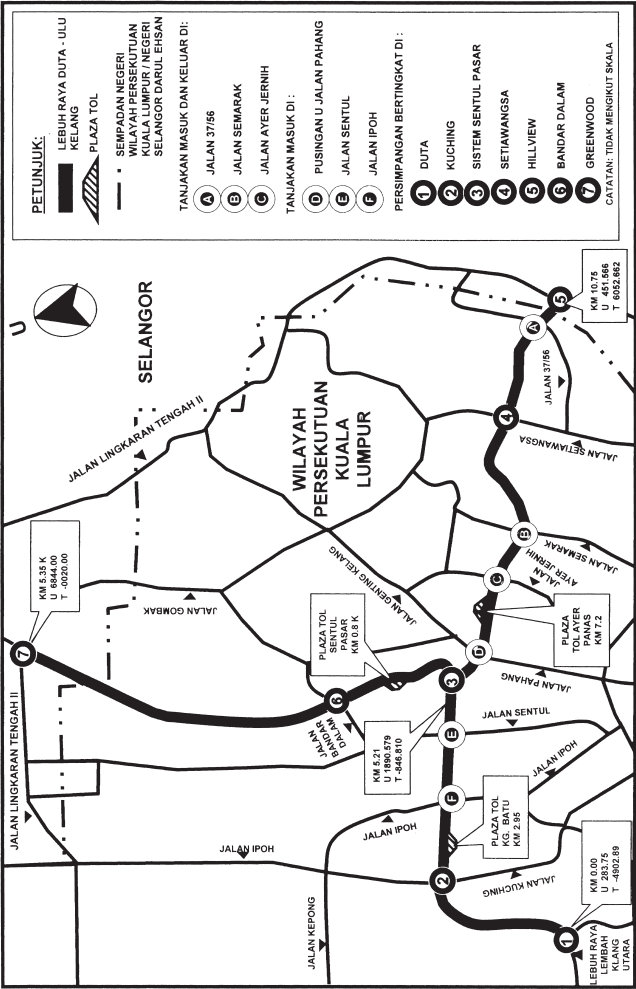

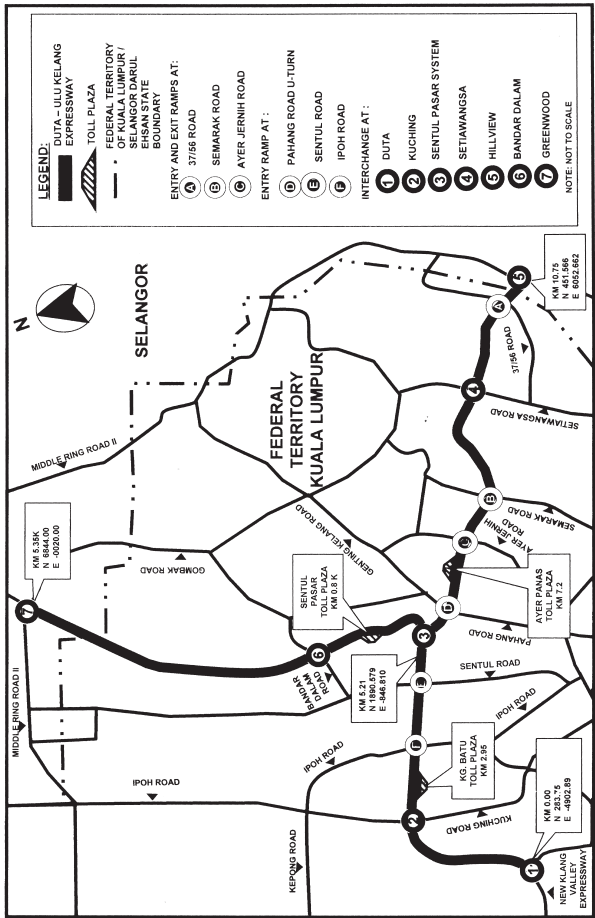
