JUDGES' REMUNERATION ACT 1971

JUDGES' REMUNERATION (AMENDMENT OF SECOND SCHEDULE) REGULATIONS 1998

Act 45.

In exercise of the powers conferred by section 19 of the Judges' Remuneration Act 1971, the Yang di-Pertuan Agong, after consultation with the Chief Justice, makes the following regulations:

Citation and
commence-
ment.

1. These regulations may be cited as the **Judges' Remuneration (Amendment of Second Schedule) Regulations 1998** and shall be deemed to have come into force on 1 March 1998.

2. The Judges' Remuneration Act 1971 is amended in the Second Schedule by substituting for paragraph 2 the following paragraph: Amendment of Second Schedule.
