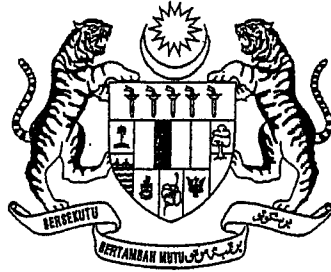

PERLEMBAGAAN PERSEKUTUAN

PERINTAH KEANGGOTAAN MAHKAMAH PERSEKUTUAN
(HAKIM-HAKIM) 1982

PADA menjalankan kuasa-kuasa yang diberi oleh Fasal (1) Perkara 122 Perlembagaan Persekutuan, Yang di-Pertuan Agong membuat Perintah berikut:

1. Perintah ini bolehlah dinamakan **Perintah Keanggotaan Mahkamah Persekutuan (Hakim-hakim) 1982** dan hendaklah mula berkuatkuasa pada 1hb Mei 1982. Nama dan mula berkuatkuasa.
2. Hakim-hakim Mahkamah Persekutuan, selain daripada Ketua Hakim Negara, Hakim-hakim Besar Mahkamah-mahkamah Tinggi dan beberapa orang hakim tambahan sebagaimana dilantik menurut Fasal (1A) Perkara 122 Perlembagaan Persekutuan, hendaklah seramai tujuh orang. Hakim-hakim Mahkamah Persekutuan.
3. Perintah Keanggotaan Mahkamah Persekutuan (Hakim-hakim) 1980 adalah dibatalkan. Pembatalan. P.U. (A) 36/80.

FEDERAL CONSTITUTION

CONSTITUTION OF THE FEDERAL COURT
(JUDGES) ORDER 1982

IN exercise of the powers conferred by Clause (1) of Article 122 of the Federal Constitution, the Yang di-Pertuan Agong makes the following Order:

Citation and commencement.

1. This Order may be cited as the **Constitution of the Federal Court (Judges) Order 1982** and shall come into force on the 1st May 1982.

Judges of the Federal Court.

2. The judges of the Federal Court, other than the Lord President, the Chief Justices of the High Courts and such additional judges as may be appointed pursuant to Clause (1A) of Article 122 of the Federal Constitution, shall be seven.

Revocation. P.U. (A) 36/80.

3. The Constitution on the Federal Court (Judges) Order 1980 is revoked.
