AKTA DADAH BERBAHAYA 1952

PERINTAH DADAH BERBAHAYA (PINDAAN) 1981

PADA menjalankan kuasa-kuasa yang diberi oleh seksyen 45A Akta Dadah Berbahaya 1952, Menteri membuat Perintah yang berikut: Akta 234.

1. Perintah ini bolehlah dinamakan **Perintah Dadah Berbahaya (Pindaan) 1981.** Nama. (No 2) (PU(A)241/S1

2. Bahagian III Jadual Pertama kepada Akta itu adalah dipinda dengan— Pindaan bagi Bahagian III Jadual Pertama. Akta 234.

- (a) memasukkan butiran "DET, N, N-diethyltryptamine" selepas sahaja butiran "Desomorphine";
- (b) memasukkan butiran-butiran "DMHP, 3-(1,2-dimethyl-heptyl)-1-hydroxy-7,8,9,10-tetrahydro-6,6,9-trimethyl-6H-dibenzo [b,d] pyran" dan "DMT, N, N-dimethyl-tryptamine" selepas sahaja butiran "Dipipanone";
- (c) memasukkan butiran "Flunitrazepam" selepas sahaja butiran "Fentanyl";
- (d) memasukkan butiran-butiran "(+)-Lysergide, (+)-N, N-diethyllysergamide (d-lysergic acid diethylamide)" dan "Mescaline, 3,4,5-trimethoxyphenethylamine" selepas sahaja butiran "Levorphanol";
- (e) memasukkan butiran "Parahexyl, 3-hexyl-1-hydroxy-7,8,9,10-tetrahydro-6,6,9-trimethyl-6H-dibenzo [b,d] pyran" selepas sahaja butiran "Oxymorphone";
- (f) memasukkan butiran-butiran "Psilocine, Psilocin, 3-(2-dimethylaminoethyl)-4-hydroxyindole" dan "Psilocybine, 3-(2-dimethylaminoethyl)-indol-4-yl dihydrogen phosphate" selepas sahaja butiran "Properidine"; dan

- (g) memasukkan butiran-butiran "STP, DOM, 2-amino-1-(2,5-dimethoxy-4-methyl) phenylpropane" dan "tetrahydrocannabinols, 1-hydroxy-3-pentyl-6a,7,10,10a-tetrahydro-6,6,9-trimethyl-6-H-dibenzo [b,d] pyran" selepas sahaja butiran "Sufentanil".

DANGEROUS DRUGS (AMENDMENT) ORDER 1981

Act 234.

IN exercise of the powers conferred by section 45A of Dangerous Drugs Act 1952, the Minister makes the following Order:—

(No. 2)

Citation:

1. This Order may be cited as the **Dangerous Drugs (Amendment) Order 1981**.

Amendment
of Part III
First
Schedule.
Act 234.

2. Part III of the First Schedule to the Act is amended by—

- (a) inserting the item "DET, N, N-diethyltryptamine" immediately after the item "Desomorphine";
- (b) inserting the items "DMHP, 3-(1,2-dimethylheptyl)-1-hydroxy-7,8,9,10-tetrahydro-6,6,9-trimethyl-6H-dibenzo [b,d] pyran" and "DMT, N, N-dimethyltryptamine" immediately after the item "Dipipanone";
- (c) inserting the item "Flunitrazepam" immediately after the item "Fentanyl";
- (d) inserting the items "(+)-Lysergide, (+)-N-N-diethyllysergamide (d-lysergic acid diethylamide)" and "Mescaline, 3,4,5-trimethoxyphenethylamine" immediately after the item "Levorphanol";
- (e) inserting the item "Parahexyl, 3-hexyl-1-hydroxy-7,8,9,10-tetrahydro-6,6,9-trimethyl-6H-dibenzo [b,d] pyran" immediately after the item "Oxymorphone";
- (f) inserting the items "Psilocine, Psilocin, 3-(2-dimethylaminoethyl)-4-hydroxyindole" and "Psilocybine, 3-(2-dimethylaminoethyl)-indol-4-yl dihydrogen phosphate" immediately after the item "Properidine"; and
- (g) inserting the items "STP, DOM, 2-amino-1-(2,5-dimethoxy 4-methyl) phenylpropane" and "tetrahydrocannabinols, 1-hydroxy-3-pentyl-6a,7,10,10a-tetrahydro-6,6,9-trimethyl-6-H-dibenzo [b,d] pyran" immediately after the item "Sufentanil".
