FEED ACT 2009

FEED (LABELLING OF FEED OR FEED ADDITIVE)
(AMENDMENT) REGULATIONS 2026

IN exercise of the powers conferred by paragraph 53(2)(e) of the Feed Act 2009 [Act 698], the Minister, after consultation with the Board, makes the following regulations:

Citation

1. These regulations may be cited as the **Feed (Labelling of Feed or Feed Additive) (Amendment) Regulations 2026**.

Deletion of regulation 3

2. The Feed (Labelling of Feed or Feed Additive) Regulations 2012 [P.U. (A) 252/2012] are amended by deleting regulation 3.
