PADA menjalankan kuasa yang diberikan oleh subseksyen 4(1) dibaca bersama subseksyen 1(8) Akta Pengurusan Strata 2013 [*Akta 757*], Menteri di Jabatan Perdana Menteri (Wilayah Persekutuan) melantik orang yang dinamakan dalam ruang (1) Jadual untuk memegang jawatan yang dinyatakan dalam ruang (2) berkuat kuasa mulai tarikh yang dinyatakan dalam ruang (3).

**Pembatalan pelantikan**

2. Pelantikan Dato' Seri TPr. (Dr.) Maimunah binti Mohd Sharif sebagai Pesuruhjaya Bangunan bagi Wilayah Persekutuan Kuala Lumpur dalam pemberitahuan Pelantikan Pesuruhjaya Bangunan dan Pembatalan Pelantikan Pesuruhjaya Bangunan bagi Wilayah Persekutuan Kuala Lumpur [*P.U. (B) 459/2024*] yang disiarkan dalam *Warta* pada 26 November 2024 dibatalkan berkuat kuasa mulai 15 November 2025 dan pelantikan Datuk Zulkurnain bin Hassan sebagai Timbalan Pesuruhjaya Bangunan bagi Wilayah Persekutuan Kuala Lumpur dalam pemberitahuan Pelantikan Timbalan Pesuruhjaya Bangunan bagi Wilayah Persekutuan Kuala Lumpur [*P.U. (B) 248/2024*] yang disiarkan dalam *Warta* pada 10 Julai 2024 dibatalkan berkuat kuasa mulai 1 Julai 2025.

## STRATA MANAGEMENT ACT 2013

APPOINTMENT AND REVOCATION OF APPOINTMENT OF  
COMMISSIONER OF BUILDINGS AND DEPUTY COMMISSIONER OF BUILDINGS FOR  
THE FEDERAL TERRITORY OF KUALA LUMPUR

IN exercise of the powers conferred by subsection 4(1) read together with subsection 1(8) of the Strata Management Act 2013 [*Act 757*], the Minister in the Prime Minister's Department (Federal Territories) appoints the persons named in column (1) of the Schedule to hold the posts specified in column (2) with effect from the dates specified in column (3).

**Revocation of appointment**

2. The appointment of Dato' Seri TPr. (Dr.) Maimunah binti Mohd Sharif as the Commissioner of Buildings for the Federal Territory of Kuala Lumpur in the notification of the Appointment of Commissioner of Buildings and Revocation of Appointment of Commissioner of Buildings for the Federal Territory of Kuala Lumpur [P.U. (B) 459/2024] published in the *Gazette* on 26 November 2024 is revoked with effect from 15 November 2025 and the appointment of Datuk Zulkurnain bin Hassan as the Deputy Commissioner of Buildings for the Federal Territory of Kuala Lumpur in the notification of the Appointment of Deputy Commissioner of Buildings for the Federal Territory of Kuala Lumpur [P.U. (B) 248/2024] published in the *Gazette* on 10 July 2024 is revoked with effect from 1 July 2025.
