MERCHANT SHIPPING ORDINANCE 1952

ALTERATION OF PORT LIMITS FOR MERSING PORT

IN exercise of the powers conferred by subsection 6(3) of the Merchant Shipping Ordinance 1952 [*Ord. 70/1952*], the Minister alters the port limits for Mersing Port in the State of Johore as prescribed in the Legal Notification No. 73 of 1953 [*L.N. 73/1953*].

Alteration of Legal Notification No. 73 of 1953

2. The Legal Notification No. 73 of 1953 is amended in the First Schedule, in respect of the State of Johore, by substituting for item "Mersing" and the particulars relating to it the following item and particulars:
