CUSTOMS ACT 1967

NOTIFICATION OF VALUE OF CRUDE PETROLEUM OIL UNDER SECTION 12

IN exercise of the powers conferred by section 12 of the Customs Act 1967 [*Act 235*], the Minister, for the purposes of the levy and payment of customs duties under the Customs Duties Order 2025 [*P.U. (A) 384/2025*], fixes in column (3) of the Schedule the value of the dutiable goods listed in columns (1) and (2).

2. This Notification has effect for the period from 1 November 2025 to 13 November 2025.
3. The Notification of Value of Crude Petroleum Oil under Section 12 [*P.U. (B) 383/2025*] is revoked.
