ELECTIONS (POSTAL VOTING) REGULATIONS 2003

NOTIFICATION UNDER SUBREGULATION 3(3) FOR THE PURPOSE
OF GENERAL ELECTION FOR THE SEAT OF THE LEGISLATIVE ASSEMBLY
OF THE STATE OF SABAH

IN exercise of the powers conferred by subregulation 3(3) of the Elections (Postal Voting) Regulations 2003 [*P.U. (A) 185/2003*], the Election Commission prescribes that the deadline for making an application to vote by post as specified in column (3) of the Schedule to the Notification under Subregulation 3(3) for the Purpose of General Election for the Seat of the Legislative Assembly of the State of Sabah [*P.U. (B) 367/2025*] published in the *Gazette* on 10 October 2025 for the persons specified in items 6, 7 and 8 of the Schedule is extended to 27 October 2025.
