STRATA MANAGEMENT ACT 2013

APPOINTMENT OF COMMISSIONER OF BUILDINGS AND REVOCATION OF APPOINTMENT
OF COMMISSIONER OF BUILDINGS FOR THE FEDERAL TERRITORY OF LABUAN

IN exercise of the powers conferred by subsection 4(1) of the Strata Management Act 2013 [Act 757] read together with subsection 1(8), the Minister appoints Mohd Sukuran bin Taib as the Commissioner of Buildings for the Federal Territory of Labuan with effect from 15 November 2024.

Revocation of appointment

2. The appointment of Haji Rithuan bin Haji Mohd Ismail as the Commissioner of Buildings for the Federal Territory of Labuan in the notification of the Appointment and Revocation of Appointment of Commissioner of Buildings and Deputy Commissioner of Buildings for the Federal Territory of Labuan [P.U. (B) 405/2023] as published in the *Gazette* on 19 September 2023 is revoked with effect from 30 September 2024.
