WEIGHTS AND MEASURES (REPEAL OF LAWS) ORDER 1981

IN exercise of the powers conferred by section 35 (1) of the Weights and Measures Act 1972, the Minister makes the *Act 71.* following Order :

2. This Order may be cited as the **Weights and Measures (Repeal** *Citation.* **of Laws) Order 1981.**

Repeal. 3. The laws specified in the Fourth Schedule of the Weights and Measures Act 1972 and all subsidiary legislations made thereunder shall be repealed on the 1st October 1981.

AKTA CUKAI PENDAPATAN 1967

PERINTAH CUKAI PENDAPATAN (PENGECUALIAN) (No. 9) 1981

Akta 53. PADA menjalankan kuasa-kuasa yang diberi oleh seksyen 127 (3) (b) Akta Cukai Pendapatan 1967, Menteri membuat Perintah yang berikut:

Nama. 1. Perintah ini bolehlah dinamakan **Perintah Cukai Pendapatan (Pengecualian) (No. 9) 1981.**

Pengecualian. 2. Menteri mengecualikan pencarum-pencarum Kumpulan Wang Simpanan Pekerja (KWSP) yang mencapai umur lima puluh lima tahun dari pembayaran cukai pendapatan berkenaan dengan anuiti yang terakru dari caruman mereka bagi tahun taksiran 1982 dan tahun-tahun taksiran berikutnya.

INCOME TAX ACT 1967

INCOME TAX (EXEMPTION) (No. 9) ORDER 1981

Act 53. IN exercise of the powers conferred by section 127 (3) (b) of the Income Tax Act 1967, the Minister makes the following Order:

Citation. 1. This Order may be cited as the **Income Tax (Exemption) (No. 9) Order 1981.**

Exemption. 2. The Minister exempts the contributors of the Employees Provident Fund (EPF) who have attained the age of fifty-five years from payment of income tax in respect of the annuity accruing from their contributions for the year of assessment 1982 and subsequent years of assessment.
