PELANTIKAN ANGGOTA SILIH GANTI LEMBAGA

PADA menjalankan kuasa yang diberikan oleh subseksyen 5(1) Akta Lembaga Lebuhraya Malaysia (Pemerbadanan) 1980 [Akta 231], Menteri telah melantik Tuan Mohd Zahrain bin Mohd Nor sebagai anggota silih ganti kepada Puan Suriyani binti Ali yang telah dilantik sebagai anggota Lembaga di bawah perenggan 4(1)(d) Akta dalam pemberitahuan Pelantikan Anggota dan Anggota Silih Ganti dan Pembatalan Pelantikan Anggota Lembaga [P.U. (B) 340/2023] yang telah disiarkan dalam *Warta* pada 15 Ogos 2023.

Tempoh pelantikan

2. Pelantikan Tuan Mohd Zahrain bin Mohd Nor sebagai anggota silih ganti kepada anggota Lembaga Puan Suriyani binti Ali berkuat kuasa mulai 1 November 2024 hingga 23 Mei 2025.

HIGHWAY AUTHORITY MALAYSIA (INCORPORATION) ACT 1980

APPOINTMENT OF ALTERNATE MEMBER OF THE AUTHORITY

IN exercise of the powers conferred by subsection 5(1) of the Highway Authority Malaysia (Incorporation) Act 1980 [Act 231], the Minister has appointed Tuan Mohd Zahrain bin Mohd Nor as the alternate member to Puan Suriyani binti Ali who has been appointed as a member of the Authority under paragraph 4(1)(d) of the Act in the notification of Appointment of Member and Alternate Member and Revocation of Appointment of Member of the Authority [P.U. (B) 340/2023] published in the *Gazette* on 15 August 2023.

Duration of appointment

2. The appointment of Tuan Mohd Zahrain bin Mohd Nor as the alternate member to the member of the Authority Puan Suriyani binti Ali shall have effect from 1 November 2024 to 23 May 2025.
