NOTICE OF EXEMPTION UNDER SUBSECTION 73(1)
(WI EDU SDN. BHD.)

IN exercise of the powers conferred by subsection 73(1) of the Interest Schemes Act 2016 [Act 778], the Minister exempts WI Edu Sdn. Bhd. from complying with section 47 of the Act, for the first three 3 years in relation to the interests in the trust deed for WI Investment Hybrid Interest Scheme, with effect from 21 December 2024 subject to the condition that WI Edu Sdn. Bhd. shall comply with any guideline in relation to the interest schemes issued by the Companies Commission of Malaysia from time to time.
