DECLARATION OF VACATIONS OF THE HIGH COURT IN MALAYA

IN exercise of the powers conferred by subrule 2(2) of the Courts of Judicature (High Court in Malaya) (Vacations) Rules 1985 [*P.U. (A) 326/1985*], the Chief Judge of the High Court in Malaya declares that the vacations of the High Court in Malaya for the calendar year 2025 shall be—

(a) from Monday, 2 June 2025 to Friday, 13 June 2025; and

(b) from Monday, 15 December 2025 to Wednesday, 31 December 2025.
