PELANTIKAN DAN PEMBATALAN PELANTIKAN ANGGOTA

PADA menjalankan kuasa yang diberikan oleh subseksyen 4(1) dan 7(1) Akta Lembaga Perindustrian Kayu Malaysia (Pemerbadanan) 1973 [*Akta 105*], Menteri telah melantik orang yang dinamakan dalam ruang (2) dan (3) Jadual masing-masing sebagai anggota dan anggota silih ganti Lembaga di bawah perenggan yang dinyatakan dalam ruang (1) bagi tempoh yang dinyatakan dalam ruang (4).
