FISHERMEN'S ASSOCIATIONS ACT 1971

APPOINTMENT AND REVOCATION OF APPOINTMENT OF
ASSISTANT REGISTRARS OF FISHERMEN'S ASSOCIATIONS

PURSUANT to subsection 6(1) of the Fishermen's Associations Act 1971 [*Act 44*], the persons named in column (1) of the First Schedule shall be the Assistant Registrars of Fishermen's Associations with effect from the dates specified in column (2).
