PEMBERITAHUAN DI BAWAH SEKSYEN 60

PADA menjalankan kuasa yang diberikan oleh seksyen 60 Akta Senjata 1960 [*Akta 206*], Menteri mengecualikan *United States of America Army Pacific* dan *Australia Rifle Company Butterworth* daripada—

- (a) pemakaian subseksyen 3(2) Akta berkenaan dengan senjata dan amunisi yang dimaksudkan semata-mata bagi maksud latihan bagi *Exercise Keris Strike 2024* antara *United States of America Army Pacific* dan *Australia Rifle Company Butterworth* dengan Tentera Darat Malaysia di Sabah dengan syarat bahawa lesen senjata yang diberikan kepada *United States of America Army Pacific* dan *Australia Rifle Company Butterworth* berkenaan dengan senjata dan amunisi itu berkuat kuasa; dan
- (b) pemakaian subseksyen 5(1) Akta berkenaan dengan senjata dan amunisi yang dimaksudkan semata-mata bagi maksud *Exercise Keris Strike 2024* antara *United States of America Army Pacific* dan *Australia Rifle Company Butterworth* dengan Tentera Darat Malaysia di Sabah.

2. Pemberitahuan ini berkuat kuasa mulai 28 Jun 2024 hingga 12 Julai 2024.

ARMS ACT 1960

NOTIFICATION UNDER SECTION 60

IN exercise of the powers conferred by section 60 of the Arms Act 1960 [*Act 206*], the Minister exempts the United States of America Army Pacific and the Australia Rifle Company Butterworth from—

- (a) the application of subsection 3(2) of the Act in respect of arms and ammunition intended solely for the purpose of training for the Exercise Keris Strike 2024 between the United States of America Army Pacific and the Australia Rifle Company Butterworth and the Malaysian Army in Sabah provided that the arms licence granted to the United States of America Army Pacific and the Australia Rifle Company Butterworth in respect of the arms and ammunition is in force; and
- (b) the application of subsection 5(1) of the Act in respect of arms and ammunition intended solely for the purpose of the Exercise Keris Strike 2024 between the United States of America Army Pacific and the Australia Rifle Company Butterworth and the Malaysian Army in Sabah.

2. This Notification has effect from 28 June 2024 to 12 July 2024.
