(A) 450/2017*] dan Perintah Wilayah Persekutuan Labuan (Ubah Suaian Akta Perhutanan Negara 1984) 2017 [*P.U. (A) 451/2017*], Menteri telah melantik Azrul Ekhuang bin Eliah sebagai Pengarah Perhutanan bagi Wilayah Persekutuan Kuala Lumpur, Wilayah Persekutuan Putrajaya dan Wilayah Persekutuan Labuan berkuat kuasa mulai 1 September 2023.

Pembatalan pelantikan

Pelantikan Mohd Hafiz bin Hamzah sebagai Pengarah Perhutanan bagi Wilayah Persekutuan Kuala Lumpur melalui pemberitahuan Pelantikan dan Pembatalan Pelantikan Pengarah Perhutanan, Timbalan Pengarah Perhutanan, Penolong Pengarah Perhutanan dan Pengawas Hutan [*P.U. (B) 107/2018*] yang disiarkan dalam *Warta* pada 28 Februari 2018 dan Pengarah Perhutanan bagi Wilayah Persekutuan Putrajaya dan Wilayah Persekutuan Labuan melalui pemberitahuan Pelantikan Pengarah Perhutanan, Timbalan Pengarah Perhutanan dan Pengawas Hutan [*P.U. (B) 5/2020*] yang disiarkan dalam *Warta* pada 3 Januari 2020 dibatalkan berkuat kuasa mulai 1 September 2023.

NATIONAL FORESTRY ACT 1984

APPOINTMENT AND REVOCATION OF APPOINTMENT OF DIRECTOR OF FORESTRY

IN exercise of the powers conferred by section 3 of the National Forestry Act 1984 [Act 313] read together with the Fifth Schedule to the Act, Federal Territory of Putrajaya (Modification of National Forestry Act 1984) Order 2017 [P.U. (A) 450/2017] and the Federal Territory of Labuan (Modification of National Forestry Act 1984) Order 2017 [P.U. (A) 451/2017], the Minister has appointed Azrul Ekhuhan bin Eliah as the Director of Forestry for the Federal Territory of Kuala Lumpur, Federal Territory of Putrajaya and Federal Territory of Labuan with effect from 1 September 2023.

Revocation of appointment

The appointment of Mohd Hafiz bin Hamzah as the Director of Forestry for the Federal Territory of Kuala Lumpur by notification of the Appointment and Revocation of Appointment of Director of Forestry, Deputy Director of Forestry, Assistant Director of Forestry and Forester [P.U. (B) 107/2018] published in the *Gazette* on 28 February 2018 and the Director of Forestry for the Federal Territory of Putrajaya and Federal Territory of Labuan by notification of the Appointment of Director of Forestry, Deputy Director of Forestry and Forester [P.U. (B) 5/2020] published in the *Gazette* on 3 January 2020 is revoked with effect from 1 September 2023.
