PEMBERITAHUAN DI BAWAH SEKSYEN 60

PADA menjalankan kuasa yang diberikan oleh seksyen 60 Akta Senjata 1960 [Akta 206], Menteri mengecualikan *United States Special Forces Operational Detachment Alpha, Charlie Company, 1st Special Forces Group (Airborne)* daripada—

- (a) pemakaian subseksyen 3(2) Akta berkenaan dengan senjata dan amunisi yang dimaksudkan semata-mata bagi maksud latihan bagi *Joint Combine Exchange Training Balance Mint 24-0133* antara *United States Special Forces Operational Detachment Alpha, Charlie Company, 1st Special Forces Group (Airborne)* dengan Unit Tindakan Khas, Polis Diraja Malaysia di Perak dengan syarat bahawa lesen senjata yang diberikan kepada *United States Special Forces Operational Detachment Alpha, Charlie Company, 1st Special Forces Group (Airborne)* berkenaan dengan senjata dan amunisi itu berkuat kuasa; dan
- (b) pemakaian perenggan 5(1)(a) dan (b) Akta berkenaan dengan senjata dan amunisi yang dimaksudkan semata-mata bagi maksud *Joint Combine Exchange Training Balance Mint 24-0133* antara *United States Special Forces Operational Detachment Alpha, Charlie Company, 1st Special Forces Group (Airborne)* dengan Unit Tindakan Khas, Polis Diraja Malaysia di Perak.

ARMS ACT 1960

NOTIFICATION UNDER SECTION 60

IN exercise of the powers conferred by section 60 of the Arms Act 1960 [*Act 206*], the Minister exempts the United States Special Forces Operational Detachment Alpha, Charlie Company, 1st Special Forces Group (Airborne) from—

- (a) the application of subsection 3(2) of the Act in respect of arms and ammunition intended solely for the purpose of training for the Joint Combine Exchange Training Balance Mint 24-0133 between the United States Special Forces Operational Detachment Alpha, Charlie Company, 1st Special Forces Group (Airborne) and the Special Actions Unit, Royal Malaysia Police in Perak provided that the arms licence granted to the United States Special Forces Operational Detachment Alpha, Charlie Company, 1st Special Forces Group (Airborne) in respect of the arms and ammunition is in force; and
- (b) the application of paragraphs 5(1)(a) and (b) of the Act in respect of arms and ammunition intended solely for the purpose of the Joint Combine Exchange Training Balance Mint 24-0133 between the United States Special Forces Operational Detachment Alpha, Charlie Company, 1st Special Forces Group (Airborne) and the Special Actions Unit, Royal Malaysia Police in Perak.

2. This Notification has effect from 11 June 2024 to 16 July 2024.
