PEMBERITAHUAN DI BAWAH SEKSYEN 60

PADA menjalankan kuasa yang diberikan oleh seksyen 60 Akta Senjata 1960 [*Akta 206*], Menteri mengecualikan *United States Seventh Fleet* dan *United States Marine Expeditionary Unit* daripada—

- (a) pemakaian subseksyen 3(2) Akta berkenaan dengan senjata dan amunisi yang dimaksudkan semata-mata bagi maksud latihan bagi *Exercise Tiger Strike 2024* antara *United States Seventh Fleet* dan *United States Marine Expeditionary Unit* dengan Tentera Darat Malaysia di Terengganu dan Pahang dengan syarat bahawa lesen senjata yang diberikan kepada *United States Seventh Fleet* dan *United States Marine Expeditionary Unit* berkenaan dengan senjata dan amunisi itu berkuat kuasa; dan
- (b) pemakaian subseksyen 5(1) Akta berkenaan dengan senjata dan amunisi yang dimaksudkan semata-mata bagi maksud *Exercise Tiger Strike 2024* antara *United States Seventh Fleet* dan *United States Marine Expeditionary Unit* dengan Tentera Darat Malaysia di Terengganu dan Pahang.

2. Pemberitahuan ini berkuat kuasa mulai 29 Mei 2024 hingga 6 Jun 2024.

ARMS ACT 1960

NOTIFICATION UNDER SECTION 60

IN exercise of the powers conferred by section 60 of the Arms Act 1960 [*Act 206*], the Minister exempts the United States Seventh Fleet and the United States Marine Expeditionary Unit from—

- (a) the application of subsection 3(2) of the Act in respect of arms and ammunition intended solely for the purpose of training for the Exercise Tiger Strike 2024 between the United States Seventh Fleet and the United States Marine Expeditionary Unit and the Malaysian Army in Terengganu and Pahang provided that the arms licence granted to the United States Seventh Fleet and the United States Marine Expeditionary Unit in respect of the arms and ammunition is in force; and
- (b) the application of subsection 5(1) of the Act in respect of arms and ammunition intended solely for the purpose of the Exercise Tiger Strike 2024 between the United States Seventh Fleet and the United States Marine Expeditionary Unit and the Malaysian Army in Terengganu and Pahang.

2. This Notification has effect from 29 May 2024 to 6 June 2024.
