APPOINTMENT OF MEMBERS OF PANELS OF THE INDUSTRIAL COURT

IN exercise of the powers conferred by paragraph 21(1)(b) of the Industrial Relations Act 1967 [*Act 177*], the Minister has appointed for the Industrial Court the persons specified in the First Schedule as the panel of persons representing employers and the persons specified in the Second Schedule as the panel of persons representing workmen with effect from 17 February 2024 to 16 February 2026.
