PERIZABAN TANAH BAGI MAKSUD AWAM

PADA menjalankan kuasa yang diberikan oleh subseksyen 62(1) Kanun Tanah Negara [*Akta 828*], sebagaimana yang diubah suai melalui Perintah Wilayah Persekutuan (Pengubahsuaian Kanun Tanah Negara), 1974 [*P.U. (A) 56/1974*] dan diwakili oleh Kerajaan Persekutuan melalui Perwakilan Kuasa di bawah Seksyen 13 [*P.U. (B) 108/2003*], Jawatankuasa Kerja Tanah Wilayah Persekutuan Kuala Lumpur—

- (a) merizabkan tanah Persekutuan yang diperihalkan dalam Jadual bagi maksud awam bagi suatu tapak untuk kolam takungan banjir; dan

NATIONAL LAND CODE

RESERVATION OF LAND FOR PUBLIC PURPOSE

IN exercise of the powers conferred by subsection 62(1) of the National Land Code [Act 828], as modified by the Federal Territory (Modification of National Land Code) Order, 1974 [P.U. (A) 56/1974] and delegated by the Government of the Federation by the Delegation of Powers under Section 13 [P.U. (B) 108/2003], the Land Executive Committee of the Federal Territory of Kuala Lumpur—

- (a) reserves the Federal land described in the Schedule for a public purpose of a site for a flood impounding reservoir; and
- (b) designates that the Director General of the Department of the Federal Territories shall have control of the reserved land in paragraph (a).
