HIGHWAY AUTHORITY MALAYSIA (INCORPORATION) ACT 1980

APPOINTMENT OF MEMBER AND ALTERNATE MEMBER
AND REVOCATION OF APPOINTMENT OF MEMBER OF THE AUTHORITY
