PEMBERITAHUAN DI BAWAH SEKSYEN 60

PADA menjalankan kuasa yang diberikan oleh seksyen 60 Akta Senjata 1960 [*Akta 206*], Menteri mengecualikan *United States of America Army Pacific* daripada—

- (a) pemakaian subseksyen 3(2) Akta berkenaan dengan senjata dan amunisi yang dimaksudkan semata-mata bagi maksud latihan bagi *Bilateral Training Keris Strike 2023* antara *United States of America Army Pacific* dengan Angkatan Tentera Malaysia di Kelantan dan Terengganu dengan syarat bahawa lesen senjata yang diberikan kepada *United States of America Army Pacific* berkenaan dengan senjata dan amunisi itu berkuat kuasa; dan
- (b) pemakaian perenggan 5(1)(a) dan (b) Akta berkenaan dengan senjata dan amunisi yang dimaksudkan semata-mata bagi maksud *Bilateral Training Keris Strike 2023* antara *United States of America Army Pacific* dengan Angkatan Tentera Malaysia di Kelantan dan Terengganu.

2. Pemberitahuan ini berkuat kuasa mulai 13 Julai 2023 hingga 15 Ogos 2023.

ARMS ACT 1960

NOTIFICATION UNDER SECTION 60

IN exercise of the powers conferred by section 60 of the Arms Act 1960 [*Act 206*], the Minister exempts the United States of America Army Pacific from—

- (a) the application of subsection 3(2) of the Act in respect of arms and ammunition intended solely for the purpose of training for the Bilateral Training Keris Strike 2023 between the United States of America Army Pacific and the Malaysian Armed Forces in Kelantan and Terengganu provided that the arms licence granted to the United States of America Army Pacific in respect of the arms and ammunition is in force; and
- (b) the application of paragraphs 5(1)(a) and (b) of the Act in respect of arms and ammunition intended solely for the purpose of the Bilateral Training Keris Strike 2023 between the United States of America Army Pacific and the Malaysian Armed Forces in Kelantan and Terengganu.

2. This Notification has effect from 13 July 2023 to 15 August 2023.
