**NOTICE TO HOLD A GENERAL ELECTION TO THE LEGISLATIVE ASSEMBLY
OF THE STATE OF SELANGOR**

WHEREAS the Legislative Assembly of the State of Selangor has become vacant in consequence of its dissolution on the 23 June 2023 by the Sultan of Selangor.

TAKE NOTICE that the Election Commission has issued election writs on 5 July 2023 to the returning officers of the State Constituencies of Selangor

specified in the Schedule hereto and that the day of nomination in respect of each State Constituency shall be 29 July 2023 and that in the event of a contested election in any of such Constituencies, the advance polling day shall be 8 August 2023 and the polling day shall be 12 August 2023.
