STRATA MANAGEMENT ACT 2013

APPOINTMENT AND REVOCATION OF APPOINTMENT OF
COMMISSIONER OF BUILDINGS FOR THE FEDERAL TERRITORY OF PUTRAJAYA

IN exercise of the powers conferred by subsection 4(1) read together with subsection 1(8) of the Strata Management Act 2013 [*Act 757*], the Minister appoints Dato' TPr. Fadlun bin Mak Ujud as the Commissioner of Buildings for the Federal Territory of Putrajaya with effect from 1 June 2022.
