LAW REFORM (MARRIAGE AND DIVORCE) ACT 1976

NOTIFICATION OF CONFERMENT OF JURISDICTION TO
SESSIONS COURT JUDGE 2023

IN exercise of the powers conferred by subsection 2(2) of the Law Reform (Marriage and Divorce) Act 1976 [Act 164], the Yang di-Pertuan Agong, on the advice of the Chief Judge of the High Court in Malaya, confers upon the Sessions Court Judges named in the Schedule jurisdiction to deal with any matter under this Act with effect from 15 June 2023.

Revocation

2. The conferment of jurisdiction to the Session Court Judges in the Notification of Conferment of Jurisdiction to Sessions Court Judge 2020 published in P.U. (B) 374/2020 on 7 August 2020 is revoked from the date of this Notification comes into effect.
