NOTICE OF TERMINATION OF ASSUMPTION OF CONTROL
(KOPERASI PENEROKA FELDA KEMAHANG (1) BERHAD)

WHEREAS, by the Co-operative Societies (Assumption of Control) (Appointment) Order 2018 [*P.U. (A) 157/2018*] published in the *Gazette* on 6 July 2018, the Malaysia Co-operative Societies Commission has appointed Amran bin Abd Kadir to assume control of the whole of the property, business, activities and affairs of the Koperasi Peneroka Felda Kemahang (1) Berhad, and carry on the whole of its business, activities and affairs for the period from 8 July 2018 to 7 July 2020 or until a Board is elected under the by-laws of the Co-operative Societies, whichever is earlier:

AND WHEREAS, by the Co-operative Societies (Assumption of Control of Koperasi Peneroka Felda Kemahang (1) Berhad) (Appointment and Revocation of Appointment) Order 2019 [*P.U. (A) 315/2019*] published in the *Gazette* on 14 November 2019, the Malaysia Co-operative Societies Commission has revoked the appointment of Amran bin Abd Kadir with effect on 15 May 2019, and the Co-operative Societies has appointed—

- (a) Hasrul Adzuan bin Hassin for the period from 16 May 2019 to 31 October 2019; and
- (b) Efende OP Andu for the period from 1 November 2019 to 7 July 2020,

to assume control of the whole of the property, business, activities and affairs of the Koperasi Peneroka Felda Kemahang (1) Berhad, and carry on the whole of its business, activities and affairs or until a Board is elected under the by-laws of the Co-operative Societies, whichever is earlier:

AND WHEREAS, by the Co-operative Societies (Assumption of Control of Koperasi Peneroka Felda Kemahang (1) Berhad) (Appointment and Revocation of Appointment) Order 2020 [*P.U. (A) 7/2020*] published in the *Gazette* on 13 January 2020, the Malaysia Co-operative Societies Commission has revoked the appointment of

Efende OP Andu with effect on 15 January 2020, and the Co-operative Societies has appointed Mohd Shihabuddin bin Mohd Yazid to assume control of the whole of the property, business, activities and affairs of the Koperasi Peneroka Felda Kemahang (1) Berhad, and carry on the whole of its business, activities and affairs for the period from 16 January 2020 to 7 July 2020 or until a Board is elected under the by-laws of the Co-operative Societies, whichever is earlier:

AND WHEREAS, by the Co-operative Societies (Assumption of Control of Koperasi Peneroka Felda Kemahang (1) Berhad) (Reappointment) Order 2020 [P.U. (A) 199/2020] published in the *Gazette* on 1 July 2020 and the Co-operative Societies (Assumption of Control of Koperasi Peneroka Felda Kemahang (1) Berhad) (Reappointment) Order 2021 [P.U. (A) 299/2021] published in the *Gazette* on 7 July 2021, the Co-operative Societies has reappointed Mohd Shihabuddin bin Mohd Yazid for the period—

(a) from 8 July 2020 to 7 July 2021; and

(b) from 8 July 2021 to 7 July 2022,

to assume control of the whole of the property, business, activities and affairs of the Koperasi Peneroka Felda Kemahang (1) Berhad, and carry on the whole of its business, activities and affairs or until a Board is elected under the by-laws of the Co-operative Societies, whichever is earlier:

AND WHEREAS, the Malaysia Co-operative Societies Commission has held an annual general meeting of the Koperasi Peneroka Felda Kemahang (1) Berhad on 30 June 2022 and twelve new Board members have been duly elected at the annual general meeting:

NOW THEREFORE, the Malaysia Co-operative Societies Commission gives notice under subsection 69D(4) of the Co-operative Societies Act 1993 [Act 502] that the assumption of control of the whole of the property, business, activities and affairs of the Koperasi Peneroka Felda Kemahang (1) Berhad made under subsections 69(2)

and 69A(2) of the Act has been terminated on 30 June 2022, and the Malaysia Co-operative Societies Commission submits the whole of the property, business, activities and affairs of the Koperasi Peneroka Felda Kemahang (1) Berhad to the newly elected Board.
