DELEGATION OF POWERS ACT 1956

DELEGATION OF POWERS UNDER SECTIONS 77 AND 84
OF THE ROAD TRANSPORT ACT 1987

IN exercise of the powers conferred by section 5 of the Delegation of Powers Act 1956 [Act 358], the Minister delegates his powers under sections 77 and 84 of the Road Transport Act 1987 [Act 333], in respect of a Federal road to the officers specified in column (1) of the Schedule for the areas specified in column (2).

Revocation of delegation of powers

2. (1) The Delegation of Powers under Section 77 of the Road Transport Act 1987 [P.U. (B) 42/1996] and the Delegation of Powers under Section 84 of the Road Transport Act 1987 [P.U. (B) 43/1996] for the State of Kedah, Perak and Johore respectively published on 1 February 1996 are revoked.

(2) The Delegation of Powers under Sections 77 and 84 of the Road Transport Act 1987 [P.U. (B) 6/2011] published on 6 January 2011 is revoked.
