PEMBETULAN

DALAM Kanun Keseksaan [Akta 574] yang dicetak semula dalam tahun 2018 dan mengandungi segala pindaan hingga 1 Oktober 2018—

- (a) dalam seksyen 89, dalam tajuk “*ILLUSTRATION*”, gantikan perkataan “in as much” dengan perkataan “inasmuch”;
- (b) dalam seksyen 300, dalam tajuk “*ILLUSTRATIONS*” yang kedua, dalam perenggan (e), gantikan perkataan “in as much” dengan perkataan “inasmuch”; dan
- (c) dalam seksyen 499—
 - (i) potong perkataan “and shall also be liable to fine”;
 - (ii) dalam tajuk “*ILLUSTRATIONS*” yang pertama—
 - (A) dalam perenggan (b), gantikan perkataan “point” dengan perkataan “points”; dan
 - (B) dalam *First Exception*, potong perkataan “and shall also be liable to fine”;
 - (iii) dalam tajuk “*ILLUSTRATIONS*” yang ketiga—
 - (A) dalam perenggan (a)—
 - (i) gantikan perkataan “in as much” dengan perkataan “inasmuch”; dan

- (ii) gantikan perkataan “appear s” dengan perkataan “appears”; dan
- (B) dalam perenggan (b), gantikan perkataan “in as much” dengan perkataan “inasmuch”; dan
- (iv) dalam tajuk “ILLUSTRATIONS” yang keempat, dalam perenggan (e), gantikan perkataan “in as much” dengan perkataan “inasmuch”.

PENAL CODE
CORRIGENDUM

IN the Penal Code [Act 574] reprinted in the year 2018 and incorporating all amendments up to 1 October 2018—

- (a) in section 89, in the heading of “*ILLUSTRATION*”, substitute for the words “in as much” the word “inasmuch”;
- (b) in section 300, in the second heading of “*ILLUSTRATIONS*”, in paragraph (e), substitute for the words “in as much” the word “inasmuch”; and
- (c) in section 499—
 - (i) delete the words “and shall also be liable to fine”;
 - (ii) in the first heading of “*ILLUSTRATIONS*”—
 - (A) in paragraph (b), substitute for the word “point” the word “points”; and
 - (B) in *First Exception*, delete the words “and shall also be liable to fine”;
 - (iii) in the third heading of “*ILLUSTRATIONS*”—
 - (A) in paragraph (a)—
 - (i) substitute for the words “in as much” the word “inasmuch”; and

- (ii) substitute for the words “appear s” the word “appears”; and
- (B) in paragraph *(b)*, substitute for the words “in as much” the word “inasmuch”; and
- (iv) in the fourth heading of “*ILLUSTRATIONS*”, in paragraph *(e)*, substitute for the words “in as much” the word “inasmuch”.
