**NOTICE TO HOLD A GENERAL ELECTION TO THE
LEGISLATIVE ASSEMBLY OF THE STATE OF PERAK**

WHEREAS the Legislative Assembly of the State of Perak has become vacant in consequence of its dissolution on 17 October 2022 by the Sultan of Perak.

TAKE NOTICE that the Election Commission has issued election writs on 20 October 2022 to the returning officers of the State Constituencies of Perak specified in the Schedule hereto and that the day of nomination in respect of each State Constituency shall be 5 November 2022 and that in the event of a contested election in any of such Constituencies, the advance polling day shall be 15 November 2022 and the polling day shall be 19 November 2022.
