PADA menjalankan kuasa yang diberikan oleh subseksyen 4(1) Akta Lembaga Perindustrian Kayu Malaysia (Pemerbadanan) 1973 [*Akta 105*], Menteri telah melantik Tuan Haji Kamaruzaman bin Othman sebagai anggota Lembaga di bawah perenggan 4(1)(*ea*) bagi tempoh mulai 17 Jun 2022 hingga 19 Disember 2022.

MALAYSIAN TIMBER INDUSTRY BOARD (INCORPORATION) ACT 1973

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBER OF THE BOARD

IN exercise of the powers conferred by subsection 4(1) of the Malaysian Timber Industry Board (Incorporation) Act 1973 [*Act 105*], the Minister has appointed Tuan Haji Kamaruzaman bin Othman as a member of the Board under paragraph 4(1)(*ea*) for the period from 17 June 2022 to 19 December 2022.

Revocation of appointment

2. The appointment of Tuan Haji Mahpar bin Atan as a member of the Board in the notification of Appointment and Revocation of Appointment of Members of the Board [*P.U. (B) 573/2021*] published in the *Gazette* on 22 November 2021 is revoked with effect from 17 June 2022.
