APPOINTMENT OF LOCK-UP TO BE A PLACE OF CONFINEMENT

IN exercise of the powers conferred by subsection 7(1) of the Prison Act 1995 [*Act 537*] read together with section 106C of the Customs Act 1967 [*Act 235*], section 50B of the Excise Act 1976 [*Act 176*], section 17B of the Free Zones Act 1990 [*Act 438*], section 72B of the Sales Tax Act 2018 [*Act 806*] and section 63A of the Service Tax Act 2018 [*Act 807*], the Minister appoints the lock-up at the Royal Malaysian Customs Department of Dengkil, Selangor to be a place for the confinement of persons, remanded or sentenced to such terms of imprisonment, not exceeding one month.
