NATIONAL WAGES CONSULTATIVE COUNCIL ACT 2011

APPOINTMENT AND REVOCATION OF APPOINTMENT OF MEMBER
OF THE NATIONAL WAGES CONSULTATIVE COUNCIL

IN exercise of the powers conferred by paragraph 5(1)(d) of the National Wages Consultative Council Act 2011 [Act 732], the Minister appoints the public officer holding the office of the Permanent Secretary, Ministry of Science, Technology and Innovation, State of Sabah as a member of the Council with effect from 3 August 2022.

Revocation of appointment

2. The appointment of the Director, Sabah State Economic Planning Unit, Sabah Chief Minister's Department as a member of the Council from amongst the public officers as in the notification of Appointment and Revocation of Appointment of Member of the National Wages Consultative Council [P.U. (B) 13/2022] published in the *Gazette* on 11 January 2022 is revoked with effect from 3 August 2022.
